

We consider the problem of the exit time of an open set for metastable non-reversible elliptic stochastic processes. We establish a correspondence between the expectation of the exit time and the inverse of the principal value of the generator. In suitable geometric frameworks, we then prove an Eyring-Kramers formula for this eigenvalue.
